INDEMNITY Definition

Definition A. The term 'Indemnified Persons' means and includes The Scout Association of Australia, Queensland Branch, The Scout Association of Australia, All Branches of The Scout Association of Australia, All subsidiary companies of The Scout Association of Australia, Queensland Branch, All subsidiary companies of The Scout Association of Australia. Every director, executive officer, officer, employee, Scouter member, servant or agent or person holding warrants from The Scout Association of Australia, Queensland Branch or The Scout Association of Australia or any Branch of The Scout Association of Australia and any persons retained in any way by The Scout Association of Australia, Queensland, or The Scout Association of Australia, whether in an official or unofficial capacity, and whether a volunteer or otherwise to supervise, direct, watch over, or assist members of The Scout Association of Australia, Queensland Branch, or The Scout Association of Australia for Branch thereof in Scouting Activities.

Definition B. "Scouting Activities" means and includes any meeting or activity organised by, or in which, The Scout Association of Australia, Queensland Branch or The Scout Association of Australia agree to participate, at whatever place, and whether identified by a name or not identified by a name relating to such meeting or activity, and any meeting or activity under the name or style of 'Queensland Branch Venture' or 'Australian Venture' or 'Jamboree'.

In consideration of The Scout Association of Australia, Queensland Branch, accepting the applicant taking part in an activity I/We agree to release, indemnify and save harmless, and at all times hereafter to keep released, indemnified, and saved harmless the Indemnified Persons, (as defined in Definition A of this Parent's Consent) from and against all liability, claims, suits, demands or actions of whatsoever nature or description, including liability, claims suits demands or actions for negligence directly or indirectly arising out of or relating to the attendance of conduct at, or travel, or travel to or from, any Scouting Activity (as defined in Definition B of this Parent's Consent) of the Applicant or ourselves or our agents except to the extent to which the Indemnified Persons shall be indemnified against such liability, claims, suits, demands or actions by an insurer under a Policy Insurance maintained by The Scout Association of Australia, Queensland Branch but without prejudice to any other rights of the Applicant or ourselves.

I/We agree to be bound by the Constitution Rules and Regulations of The Scout Association of Australia, Queensland Branch being those existing as at the time of acceptance of the Applicant as a member, and thereafter as lawfully modified or amended or added to from time to time.

I/We acknowledge that I/We have been informed that a copy of the Insurance Policy maintained by The Scout Association of Australia, Queensland Branch and a Schedule of cover under that Policy of Insurance are available for me/us to inspect, should I/We wish to do so.

I/We acknowledge that the intent of this Parent's Consent may be pleased in limitation of liability for the Indemnified Persons.

I/We acknowledge that the intent of this Parent's Consent is to benefit the Indemnified Persons and agree, for the purposes of section 55 of the Property Law Act Queensland, that acceptance of the Applicant as a member of The Scout Association of Australia, Queensland Branch will constitute an acceptance by all the Indemnified Persons of the benefit conferred by this Application for Membership.
